## NOTE

- 1. He / She shall have to apply for renewal of R.C. to the Registering Authority not less than one month before the expiry date of this certificate duly depositing the renewal fees. Renewal fee at the rate prescribed under Rule-9 is to be paid through online under head of account "0059-80-800-0194-02242". After submission of Renewal application through online in Form-C, the contractor has to submit hard copy of online application before the Registering Authority.
- 2. Failure to apply for renewal in due time will render the contractor liable to a penalty under Rule-10 equal to renewal fee for the first three months of default or part thereof. Thereafter, the amount of penalty will be equal to the renewal fee for every month of default.
- 3. Work list / Valid Tender Certificate on Form-G duly certified by the concerned Authority / GST / PAN / Passport photo duly attested, be furnished for renewal of the R.C.
- 4. To apply for renewal means to apply in the prescribed manner. Application without list of works executed, valid tenders and renewal fee as prescribed for each class of contractor under Rule-14 will not be treated as a valid application and render the contractor liable for penalty.
